Community Overdose Action Team (COAT)

- Per the Montgomery County Coroner's Office, there were **566** accidental overdose deaths for calendar year 2017.
- Per the Montgomery County Coroner's Office, there have been 128 accidental overdose deaths as of June 28, 2018.
- Operational period is now 60 days instead of 30.
